Real Time Pre-Pay Program

The Real Time Pre-Pay Program (RTP) offers customers the opportunity to capitalize on energy market “dips.” Contract prices will be posted weekly by Monday 10:00 a.m. at www.countrycomfort.org or by calling the RTP hotline at 715-357-3339. Country Comfort will offer 3 direct mail contract offers in addition to the weekly RTP. Each offer is priced independently from the prior.

1. Must have account established with Country Comfort prior to completing RTP contract
2. Full payment due with contract (unless purchasing greater than 2,500 gallons)
3. Contracts must be completed entirely to be valid
4. Delivery on contracted gallons is from September 15, 2009 - April 30, 2010

5. Contracts can be mailed to Country Comfort, LLC, PO Box 197, Barron, WI 54812, faxed or dropped off at Country Comfort’s office by 4:30 p.m. on Friday or postmarked by close of day on Friday of the week the propane is purchased otherwise the customer is subject to the price the following week (higher of the two prices will be applied)

A. Contract Terms for 2009 – 2010 PROPANE CONTRACTS

1. Customer account must be current in order for contract to be accepted.
2. All contract programs offer a fixed price. Prices do not go down if markets go down.
3. 300-gallon minimum purchase. If a propane contract had been written on a prior offer, we will accept purchases less than 300 gallons.
4. Gallons will be delivered from the first completed contract and end with the last propane contract completed. Customers are able to write up to 3 different contracts from various offers made throughout the year.
5. Delivery of the propane under all propane contracts will begin September 15, 2009 and end April 30, 2010.
6. To guarantee delivery of remaining contract volume, customers must call by the third week in April 2010. Orders placed the last week of April will be assessed a special trip charge of \$10.00. Please give us advance notice so we can schedule efficiently.
7. All unused dollars at the end of the contract time will appear as a credit on the customer account and can be used for future purchases. Gallons associated to the contract are void.
8. Any propane delivered beyond the contracted gallons or after the contract expiration date will be delivered at the regular market price in effect at the time of the purchase.
9. If contracted gallons do not cover entire delivery, a minimum of 250 gallons or a fill is required, and will be at current truck price.
10. All contract plans are non-transferable to other accounts or locations.
11. Default Fee: If Country Comfort determines that the customer has defaulted or neglected to use less than 50% of the total contracted volume, Country Comfort reserves the right to retain 50 cents per gallon on those gallons less than 50% of the total purchased.

B. Additional Terms Applicable to ONLY the Deposit Plan

1. Large volume or commercial consumers can complete a deposit contract; please call (877)407-2132 for details.
2. Deposit Contract Plan is only available to residential propane consumers during our traditional August offer (Direct mail).

C. SPECIAL NOTES:

1. **Auto-Fill Customers Only:** A propane delivery will automatically be created if tank is estimated to be less than 30% full. If Country Comfort estimates the propane inventory in the customer tank to be greater than 30%, then the customer will need to place an order if the remainder of the contracted propane volume is desired.
 2. **Level Pay Budget Plan Customers:** The prepay and deposit contracts do not pertain to the current program you are participating in. If you choose to take advantage of one of the current offers, then you will need to discuss adjusting your payment plan with a customer service representative. Please continue payments as scheduled to remain current.
 3. **Payment:** Please allow two weeks after deadline for processing your payment. Thank you.
